

FINAL INSTRUCTIONS FOR RENEWAL OF NOTARY PUBLIC COMMISSION APPLICATION

IMPORTANT - YOU MUST COMPLETE THESE INSTRUCTIONS TO MAKE YOUR NOTARY COMMISSION ACTIVE AND OFFICIAL!

Please follow these steps to complete the application process:

1. Sign your Application in Section III A in the presence of a Notary Public.
2. Have the Notary Public who witnessed your signature sign the Application in Section III B.
3. Take the completed Application to the DOUGLAS Superior Court Clerk's office for processing. The address and phone number is as follows:

Effective July 1, 2024,

- All **New and Renewal** applicants must include a criminal background check performed by a local law enforcement agency with their application.*
- All **New and Renewal** applicants must complete the online notary training and exam and pass with a score of 90% or above (available at: <https://eLearn.gscca.org>). There is a \$2 fee associated with the exam.*

**Exemption for attorneys only - Must present a current Georgia Bar card.*

The fee for a notary commission is **\$55.00** for a four year term. Douglas County Clerk of Superior Court accepts cash, local checks, or money orders (payable to Douglas County Clerk of Superior Court) for payment. Office hours are 8:00 a.m. to 5:00 p.m. Monday through Friday (scheduled holidays excluded).

The applicant must use their residential address in the application. Applicants must bring their **completed application**, the **exam Certificate of Completion**, and a **criminal background check issued by a local law enforcement agency** (no more than 30 days old) to the Douglas County Clerk of Superior Court office for processing within 30 days of the online entry. Applications not processed within 30 days will be deleted from the online site and the applicant will be required to re-enter all information.

All applicants must bring government or state issued identification for verification of identity and residency (i.e.: valid driver's license; valid passport; valid voter identification card; or such other valid identification by a local or state government or by the United States government).

All **NEW** applicants must provide the names of two endorsers. Endorsers must be Douglas County residents, have known you for over 30 days, and may not be related to you. You must provide their residential address, a telephone number and they must sign the application.

Renewal applications are valid only for those holding a current, unexpired appointment from Douglas County. You may renew 30 days prior to your expiration date, but you must renew on or before the expiration date.
