Application Deadlines, Sign Posting, and Hearing Schedule

Douglas County Planning and Zoning Department shall hold a community information meeting in advance of the regularly scheduled zoning hearing for every application for rezoning and special use permit. The meetings will be held on the specified date for the appropriate meeting on the attached schedule. The applicant or their representative is strongly encouraged to attend the meeting and should be prepared speak to citizens who are present with questions about their application. The applicant's contact information, as provided on the application, will be shared with members of the public with an interest in the application. All Staff Reports will be posted one week before the hearing date on the county website.
