1. You should consult your attorney in the event you have any questions.
2. An answer must be filed within forty-five (45) days after the date of service of the Summons of Garnishment.
3. You are required to file further answers no later than 45 days after your last answer.
4. File your answer at the Magistrate Clerk's office and mail a copy to the plaintiff or plaintiff's attorney and the Defendant or Defendant's Attorney.
5. Please send one check per Answer, per case. If you have multiple garnishment cases with the Magistrate Court, ***do not*** combine checks.
6. A reply by letter is insufficient, even though you do not employ the defendant. You should file all answers on the Garnishee Answer to Continuing Garnishment form.
7. **PLEASE NOTE: THE FULL AMOUNT TO BE PAID IS FOUND ON THE *SUMMONS OF
CONTINUING GARNISHMENT*.**
8. Checks are to be made payable to: **Clerk of Magistrate Court**.

Thereafter, you are required to file further answers no later than 45 days after your last answer. Every further answer shall state what money, including wages, and other property, except what is known to be exempt, belonging to the Defendant or obligations owed to the Defendant you hold or owe at and from the time of the last answer to the time of the current answer. **YOU MUST FILE ADDITIONAL ANSWERS UNTIL THE ORIGINAL ARREARAGE IS RETIRED AND ALL PERIODIC SUPPORT PAYMENTS ARE CURRENT.** Money, including wages or other property admitted in an answer to be subject to continuing garnishment must be paid or delivered to the Court concurrently with each answer. The Plaintiff and the Defendant are required by law to serve you with a copy of any amendment or modification to the original judgment.

Should you fail to file Garnishee Answers as required by this summons, a judgment by default will be rendered against you for the amount remaining due on a judgment as shown in the Plaintiff's Affidavit of Continuing Garnishment.

IMPORTANT INSTRUCTIONS—CONTINUING GARNISHMENT

1. If the Defendant listed in this summons is not presently employed by the Garnishee or said Defendant's employment is terminated after service of this summons, then state this on the Garnishee Answer to Continuing Garnishment form.
2. File your Answer at the Magistrate Court of Douglas County, Douglas County Courthouse, 8700 Hospital Drive, Douglasville, Georgia 30134.
3. If you are not familiar with the Georgia law applying in garnishment cases, consult your attorney, or otherwise obtain correct information before paying the Defendant any sum after you have been served with this Summons of Garnishment.
4. A reply by letter is insufficient, even though you do not employ the Defendant. You must file an answer as provided by law.
5. Plaintiff, or Plaintiff's attorney, are the only persons who can authorize the Court to issue a release and relieve you of filing an Answer to this Summons. This authorization must be in writing and filed with the Clerk's office.
6. Failure to file an Answer may result in a default judgment being entered against Garnishee for the amount claimed by Plaintiff against Defendant, plus court cost.

1. Defendant may file a Defendant's Claim Form if he/she believes there is money or property that is exempt from the garnishment.
2. If you are unfamiliar with the Georgia law applying to garnishments, consult an attorney, or otherwise obtain correct information before proceeding in this matter.
3. File your Defendant's Claim Form at the Magistrate Court of Douglas County, Douglas County Courthouse, 8700 Hospital Drive, Douglasville, Georgia 30314.
4. Failure to file a Defendant's Claim Form will result in a conclusive presumption that the garnishment was properly issued.
5. Garnishment against the property and credits of the Defendant has been or will be served on the Garnishee.

**NOTICE TO DEFENDANT OF RIGHT AGAINST GARNISHMENT
OF MONEY, INCLUDING WAGES, AND OTHER PROPERTY**

You received this notice because money, including wages, and other property belonging to you have been garnished to pay a court judgment against you. **HOWEVER, YOU MAY BE ABLE TO KEEP YOUR MONEY, INCLUDING WAGES, OR OTHER PROPERTY. READ THIS NOTICE CAREFULLY.**

State and federal law protects some money, including wages, from garnishment even if it is in a bank. Some common exemptions are benefits from social security, supplemental security income, unemployment, workers' compensation, the Veterans' Administration, state pension, retirement funds, and disability income. This list of exemptions does not include all possible exemptions. A more detailed list of exemptions is available at the Clerk of Court's office located at The Magistrate Court of Douglas County, 8700 Hospital Drive, Douglasville, Georgia 30134, and on the website for the Attorney General (www.law.ga.gov).

Garnishment of your earnings from your employment is limited to the lesser of 25 percent of your disposable earning for a week or the amount by which your disposable earnings for a week exceed \$217.50. More than 25 percent of your disposable earnings may be taken from your earnings for the payment of child support or alimony or if a Chapter 13 bankruptcy allows a higher amount.

**TO PROTECT YOUR MONEY, INCLUDING WAGES, AND OTHER PROPERTY FROM BEING
GARNISHED, YOU MUST:**

1. Complete the Defendant's Claim Form as set forth below; and
2. File this completed claim form with the Clerk of Court's office located at The Magistrate Court of Douglas County, 8700 Hospital Drive, Douglasville, Georgia 30134.

FILE YOUR COMPLETED CLAIM FORM AS SOON AS POSSIBLE. You may lose your right to claim an exemption if you do not file your claim form within 20 days after the Garnishee's Answer is filed or if you do not mail or deliver a copy of your completed claim form to the Plaintiff and the Garnishee at the address listed on this notice.

The Court will schedule a hearing within ten days from when it receives your claim form. The Court will mail you the time and date of the hearing at the address that you provide on your claim form. You may go to the hearing with or without an attorney. You will need to give the Court documents or other proof that your money is exempt.

The Clerk of Court cannot give you legal advice. **IF YOU NEED LEGAL ASSISTANCE, YOU SHOULD SEE AN ATTORNEY.** If you cannot afford a private attorney, legal services may be available.
