INSTRUCTIONS FOR SERVICE BY PUBLICATION

If you do not know where your spouse resides or you are seeking a divorce and your spouse has never lived in Georgia, then you must serve your spouse by publishing a notice in the Douglas County Sentinel. To do this, you must complete the following steps:

1. Prepare your Petition. Make sure that it is stated in your petition that it is being served by publication. (*Keep a copy of your petition for your file.*)
2. If you do not know where the other party lives or works, complete an **Affidavit of Diligent Search** which can be found on www.celebratedouglascounty.com
3. File your original Petition for Divorce along with the Affidavit of Diligent Search in the Douglas County Superior Court Clerk's Office.

In addition to the normal filing fee, you must also pay a publication fee which is paid to the Douglas County Sentinel.
